On February 22, 2018, the 18<sup>th</sup> Ngarchelong State Assembly on its Tenth Special Session adopted Resolution No. 18-08 to propose an amendment to Article XV, Section 1(b) of Ngarchelong Constitution to reduce or lessen the percentage of voters required to amend the Constitution, which is to reduce or lessen from  $\frac{3}{4}$  (75%) to 60%. If seventy-five percent (75%) of total vote casts on this proposed amendment is in affirmative, the amendment to Article XV, Section 1(b) shall be made.


